ALTAREA COGEDIM SUCCESSFULLY ISSUES A RATED €500M BOND

This rated bond, with a maturity of 8 years, bears a 1.875% coupon. The settlement is scheduled for 17 October 2019.

Proceeds will be used for the refinancing of secured debt and for general corporate purposes, and will strengthen the Group's financing structure by lengthening the maturity of its debt. This operation is in line with the Group's strategy of disintermediation of its financing resources.

Alain Taravella, President and Founder of Altarea Cogedim comments: "the success of this operation demonstrates the investors' confidence in Altarea Cogedim's specific business model, as both a property owner and developer, and in the quality of its credit profile".

This transaction was led by Crédit Agricole CIB, Morgan Stanley, Natixis and Société Générale Corporate & Investment Banking as Active Joint Bookrunners, BNP Paribas, Crédit Industriel et Commercial SA and HSBC Bank PLC as Passive Bookrunners.
